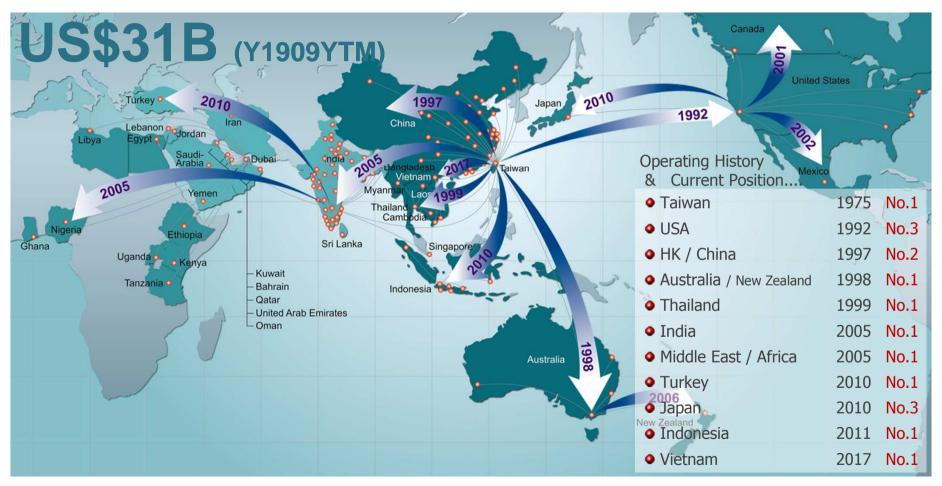

Worldwide Footprint



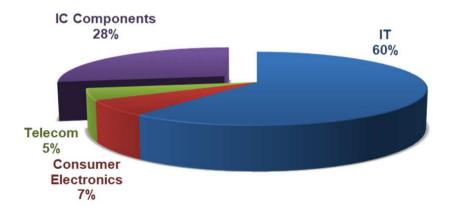

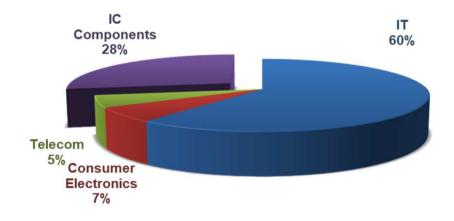

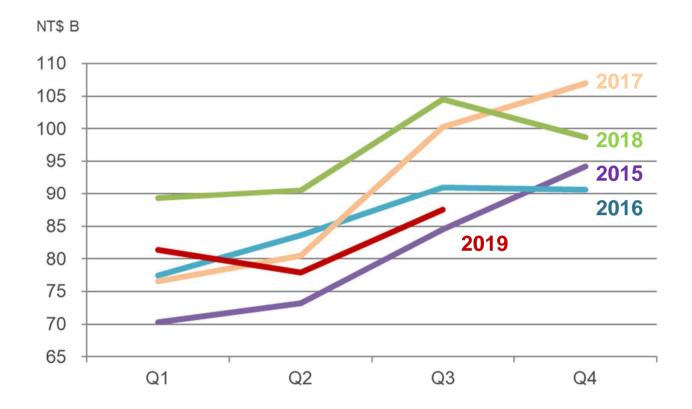

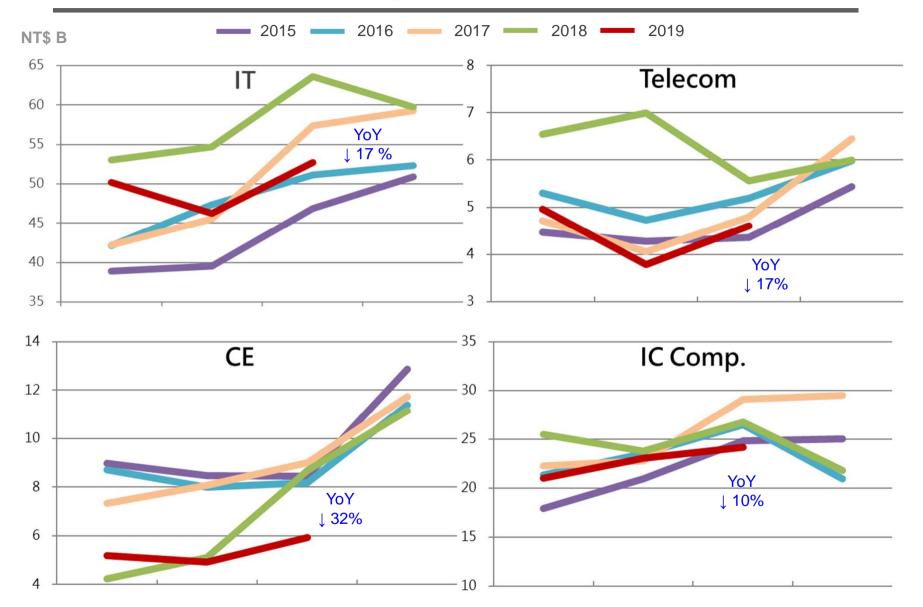

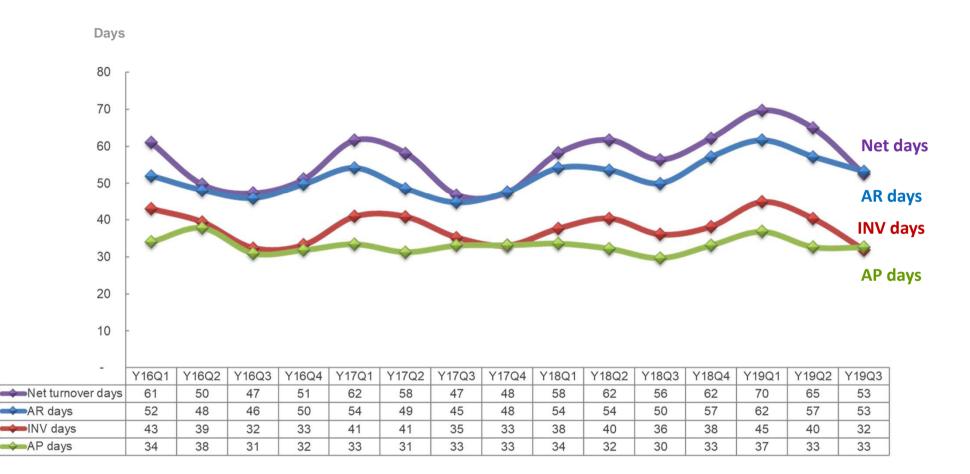

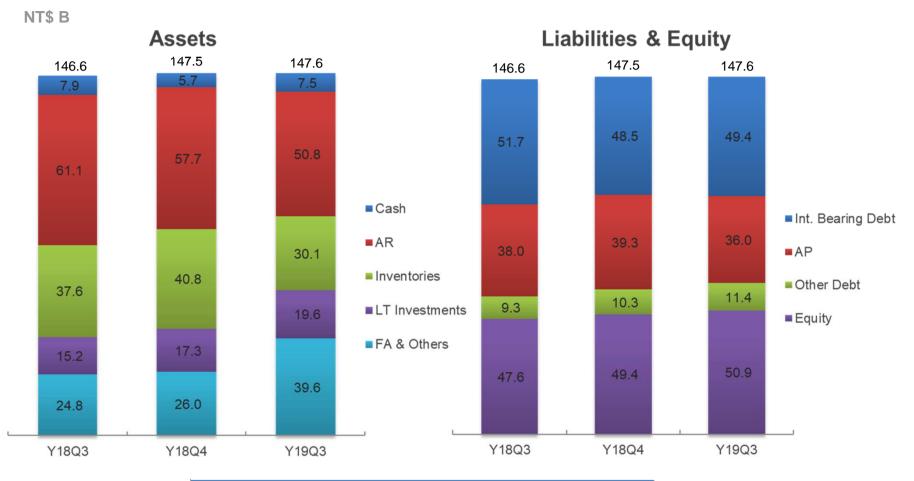
